PARENTAL WAIVER, RELEASE OF LIABILITY, SOVEREIGN IMMUNITY, AND CONSENT FORM
(To be completed and signed by parent/guardian for contestants under 18 years of age)

I, the undersigned, as the parent or legal guardian of the child named above, do hereby: (1) give my full consent and approval for my child to take part as a contestant in the Gila River Indian Community's 59th Annual Mul-Chu-Tha All Indian Junior Rodeo held on March 17, 2023 and within the exterior boundaries of the Gila River Indian Reservation; (2) acknowledge that the Gila River Indian Community ("Community") is a federally recognized Indian Tribe and that the departments and programs of the Community are tribal departments of the Community; and (3) Further, acknowledge that the Community, its Departments and programs are protected by the doctrine of tribal sovereign immunity, not subject to suit by the undersigned parent or legal guardian, and that the Community has not waived its sovereign immunity from suit with respect to any claims, demands, or causes of action asserted by the undersigned for any loss, damage, injury, including death, or negligence, which may have resulted from my child's participation in the above-referenced event(s).

In consideration of being allowed to participate in the Community's Mul-Chu-Tha All Indian Junior Rodeo, March 17, 2023, the receipt of such permission hereby acknowledged, I, the undersigned parent or legal guardian, hereby release, discharge, waive and relinquish the Community, its sponsors and volunteers from any and all liabilities, claims, or legal actions whatsoever arising out of or related to any loss, damage, or injury, including death which may be sustained by me or my child or by any property in my or my child's possession or control, while in, on, or upon the premises and for participation as a contestant.

PARENTAL WAIVER, RELEASE OF LIABILITY, SOVEREIGN IMMUNITY, AND CONSENT FORM (Cont.)

I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for negligent acts or other conduct by the officers, employees, administrators and volunteers of the Gila River Indian Community and for the operation of the Mul-Chu-Tha Fair and Rodeo.

I ACKNOWLEDGE THAT I HAVE READ THE ABOVE WAIVER, RELEASE OF LIABILITY, SOVEREIGN IMMUNITY AGREEMENT, AND CONSENT FORM, AND BY SIGNING I AGREE IT IS MY INTENTION TO EXEMPT AND RELIEVE THE GILA RIVER INDIAN COMMUNITY FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE.
